Psi Iota Xi Sorority is a National Philanthropic Organization with the Zeta Mu Chapter located in Jasper, Indiana.

The Zeta Mu Chapter was originally chartered in 1956 by twenty-one women from our community. Zeta Mu funds many local activities including a summer language and literacy camp, funding an annual scholarship, sponsoring a Girl's State delegate, Psi Ote Totes (books for local libraries) and supporting JCAC.

Psi Iota Xi Sorority was found in Muncie, Indiana in 1897 – the first of its kind in Indiana. Psi Iota Xi has grown to approximately 150 Chapters with about 5,000 active members in Illinois, Indiana, Kentucky, Michigan, Ohio and Tennessee.

The primary purpose of Psi Iota Xi is to be of service with time, money and love in a cooperative effort within the community. Psi Iota Xi has gained national recognition for its work, especially with children, in the field of speech and hearing.

Nationally, Psi Iota Xi donates over one million dollars to philanthropic projects each year.

The National Organization promotes philanthropic projects on a broad scale. A brochure entitled "How does Your Child hear and Talk" was developed and funded by Psi Iota Xi. It has been distributed internationally in English and Spanish through the American Speech-Language-Hearing Association. This brochure is an aid to many parents, doctors and professionals.

- No open bottles or glasses of wine will be allowed outside of the wine garden. No smoking is allowed anywhere on the premises.
- Special request must be made with application. Requests are not guaranteed.
- Set up time will be from 7:45 a.m. until 9:15 a.m. After 9:15 a.m. **NO Vehicles** will be allowed in the exhibit area.
- Booth locations will be pre-assigned by the committee.

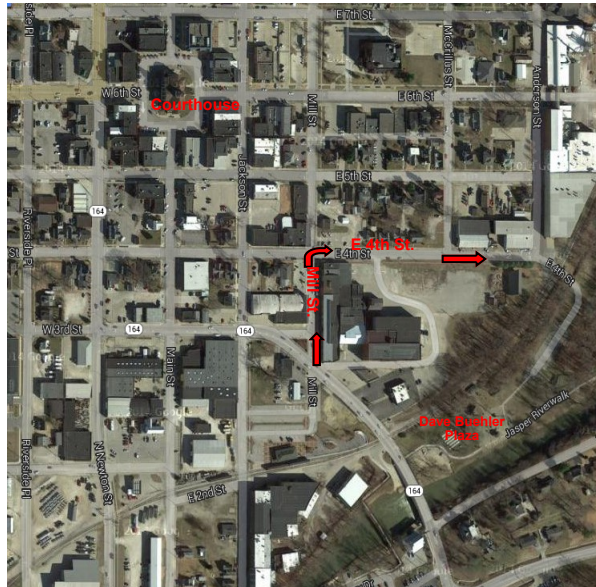
- All proceeds from wine booth sales go to the individual exhibitors. Exhibitors are responsible for collecting and paying Indiana State sales tax where applicable
