Jasper Strassenfest and ACT Waiver for 2019 Trike Rennen

In consideration of being allowed to participate in the Jasper Strassenfest and the activity sponsored by Actors Community Theatre, the undersigned:

Agree that prior to participating, they and their parents each will inspect the facilities and equipment to be used and will refuse to participate to if they believe anything to be unsafe.

Acknowledge and understand that each participant will be engaging in activities that will involve risk of serious injury, including permanent disability and death, which may not result not only from their own actions, inactions, or negligence of others, rules of play, or the conditions of the premises or of any equipment used. Further, that there may be other risks not known to us or reasonably foreseeable at the time.

Assume all foregoing risks and accept personal responsibility for damages following such injury, permanent disability, or death.

Release, waive, forever discharge and covenant not to sue the Jasper Strassenfest, Inc., the Jasper Strassenfest Committee, its affiliated clubs, their respective administrators, agents, directors, coaches, and other employees of the organizations, other participants, the Event Organization, sponsoring agencies, sponsors, advertisers and if applicable, owners or leasers of premises used to conduct the event, all of which are here inafter referred to as "releasees" from demands, losses, or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.

I, hereby, for myself, my minor child (if applicable), my administrators, heirs and assigns, hereby release, waive and forever discharge the City of Jasper, its boards, elected and appointed officials, and its employees, for property damage or personal injury, including death, that may arise or grow out of my participation in this event/activity-or my child's participation. I also agree to indemnify and hold harmless the City of Jasper, it's boards, elected and appointed officials, and its employees in any claim, expenses or action, including attorney fees, assessed or brought against them because of my acts or omissions or the acts or omissions of my minor child.
